A new monitoring location is currently being determined.</p> <p>Mains power to Northern Grounds Monitor was restored 3.30pm 15 April after it was disconnected 8.30am, 12 April.</p> <p>Insufficient data was collected for a valid 24 hr average (loss of six hours data collection), on Block 9 (solar powered monitor), when the monitoring station battery voltage dropped below 11.3 V, between 2am – 8am on the 6th to 9th April. There were two 24-hour exceedances of the PM_{2.5} Air (EPP) criteria on ambient particulate monitor in the community park, during this reporting period. These exceedances occurred on the 10 May and 12 May, and are summarised in the tables below:

Comment:

The 24-hour average PM_{2.5} concentration measured at Community Park of 26.8 $\mu\text{g}/\text{m}^3$ exceeded the EPP Air criterion of 25.0 $\mu\text{g}/\text{m}^3$. All ABC monitors (on site and off site), showed similar particulate levels and trends. This indicates the particulate level was from a localised air shed condition, rather than related to any specific site activity. Low wind speeds and overnight temperatures resulted in increased particulate levels overnight / early morning, which dropped during the day as wind speed and temperatures increased. PM_{2.5} particulate is commonly produced from combustion sources (vehicles/ heaters). PM_{2.5} particulate levels/trends are indicative of low night time temperatures, low wind speeds and reduced reduced air shed flushing.

Comment:

The 24-hour average PM_{2.5} concentration measured at Community Park of 29.7 $\mu\text{g}/\text{m}^3$ exceeded the EPP Air criterion of 25.0 $\mu\text{g}/\text{m}^3$. All ABC monitors (on site and off site), showed similar particulate levels and trends. This indicates the particulate level was from a localised air shed condition, rather than related to any specific site activity. Also the wind movement for this 24 hr period was predominantly (75% of the day) blowing towards ABC. Low wind speeds and overnight temperatures resulted in increased particulate levels overnight / early morning, which dropped during the day as wind speed and temperatures increased. PM_{2.5} particulate is commonly produced from combustion sources (vehicles/ heaters). PM_{2.5} particulate levels/trends are indicative of low night time temperatures, low wind speeds and reduced reduced air shed flushing.

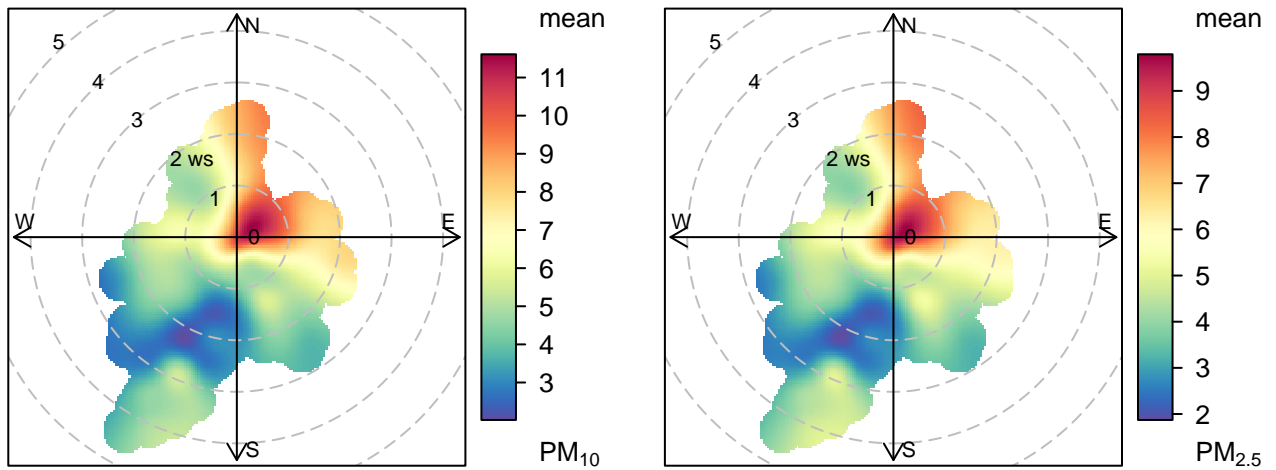


Community Park – 24-hour average PM_{2.5}

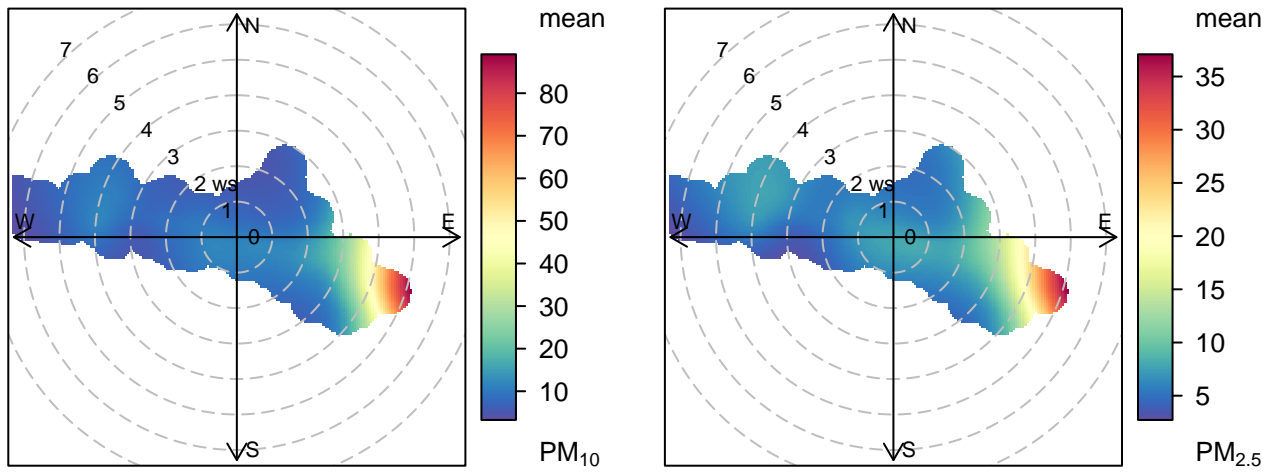


Northern Grounds – 24-hour average PM_{2.5}



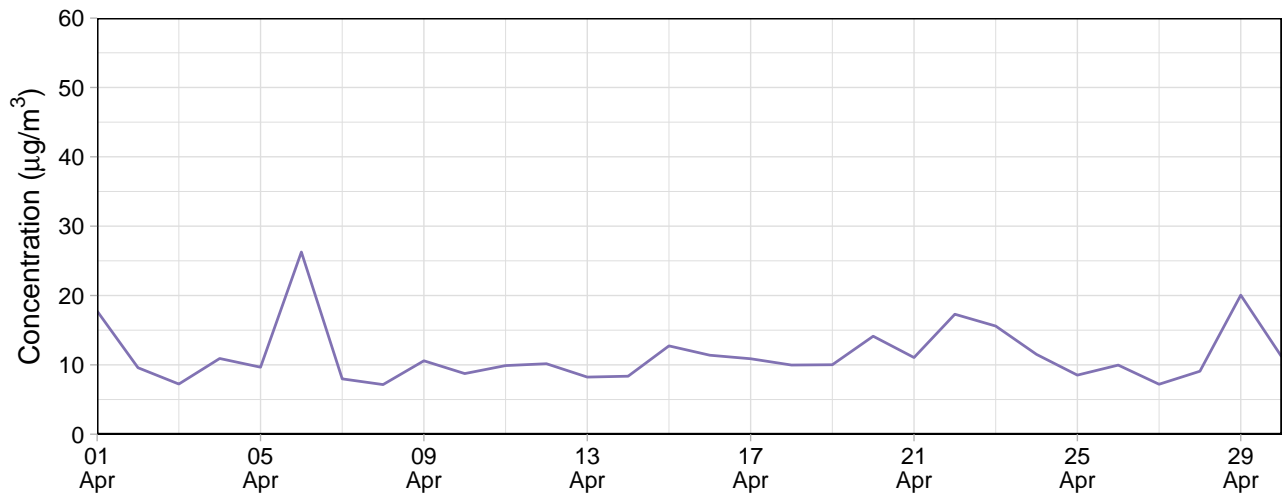


Frequency of counts by wind direction (%)

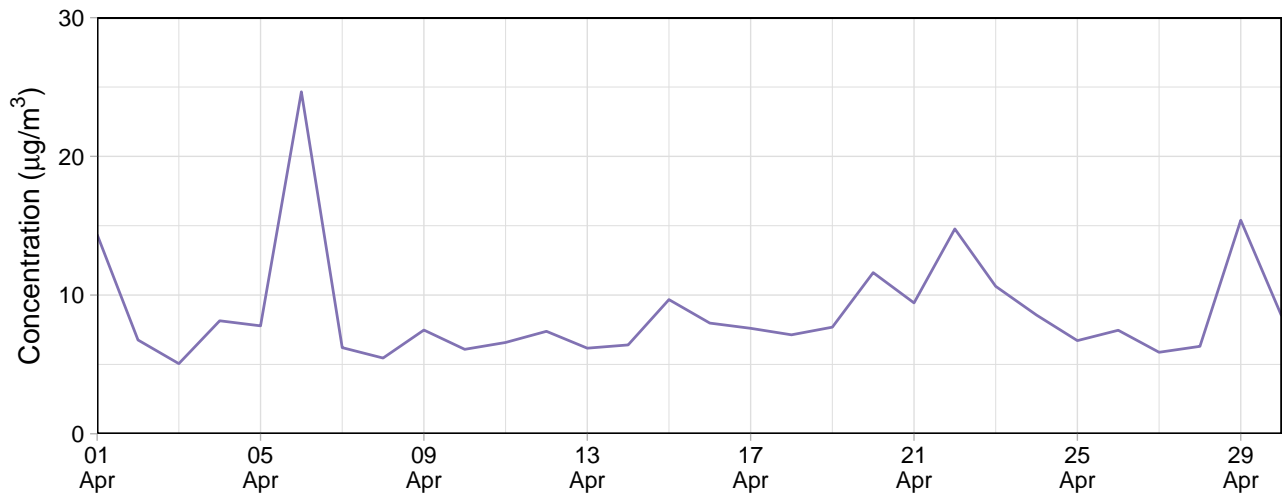


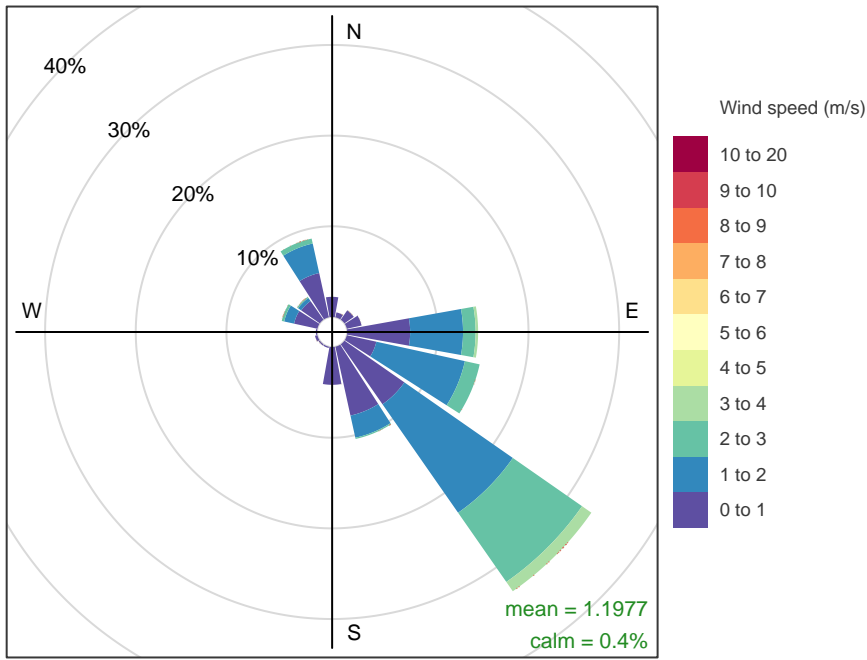

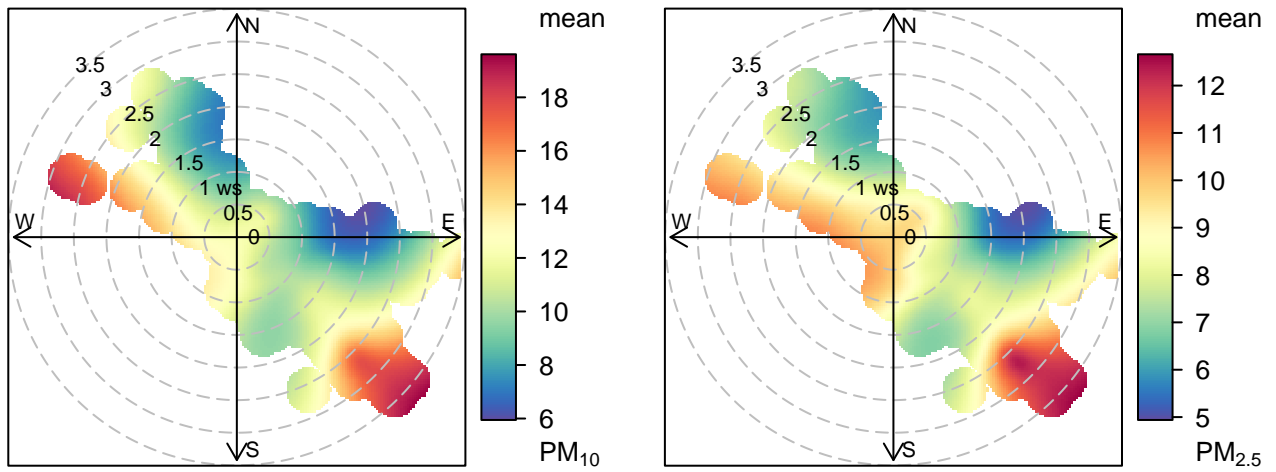


Eastern Grounds – 24-hour average PM_{2.5}



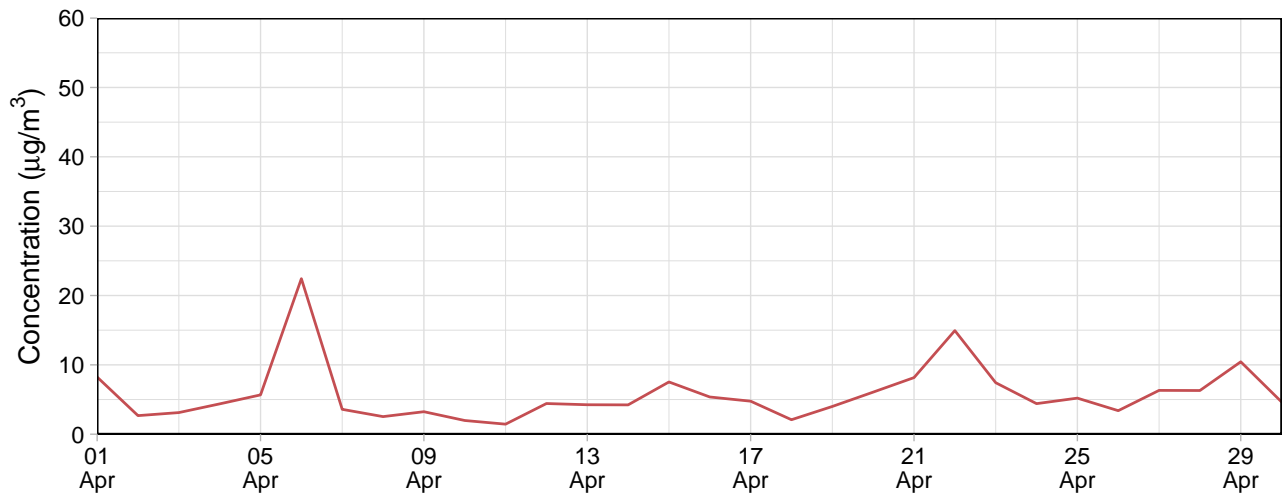

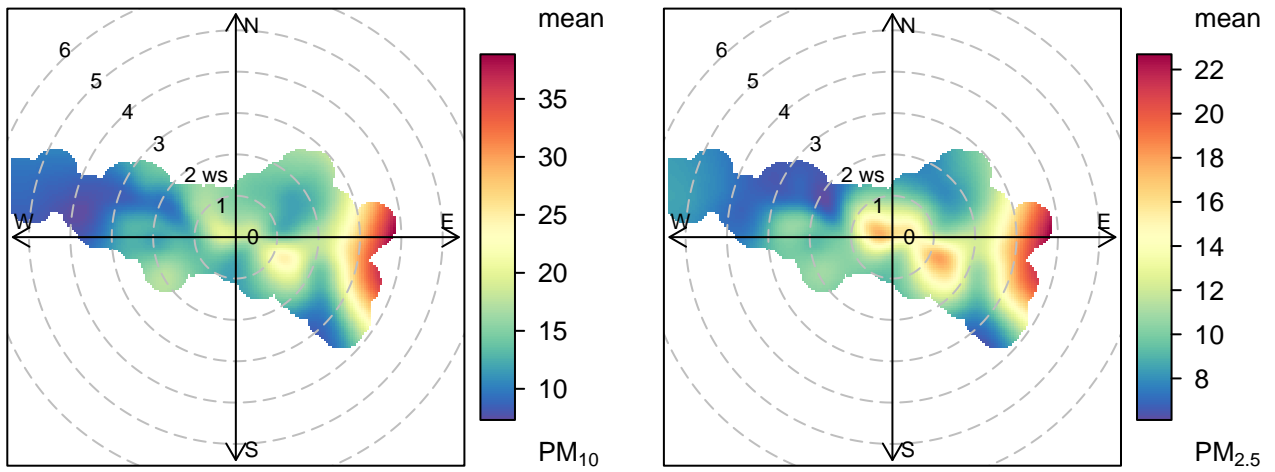


Northern Grounds – 24-hour average PM_{2.5}



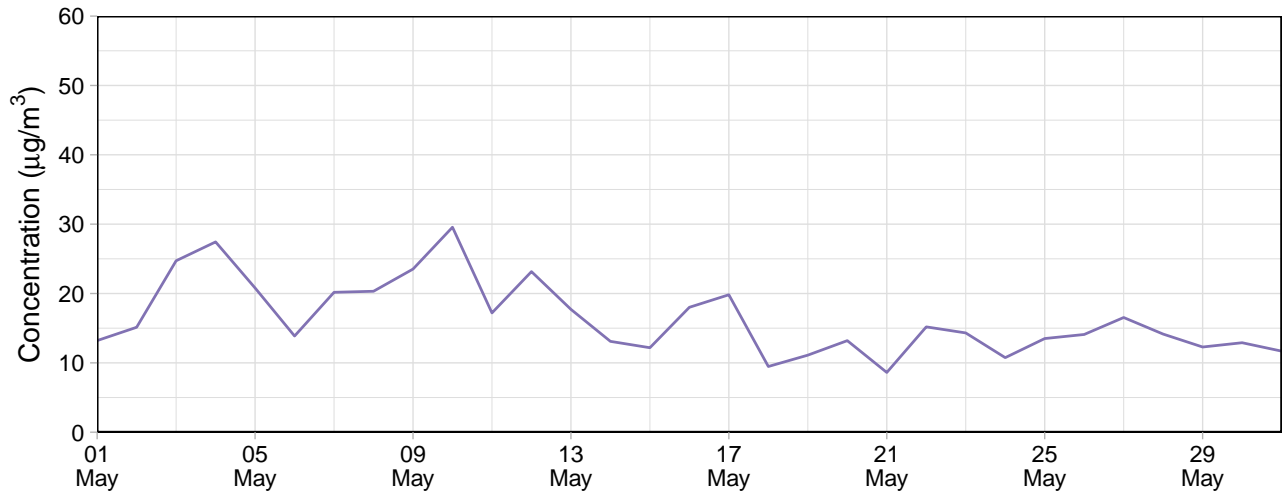

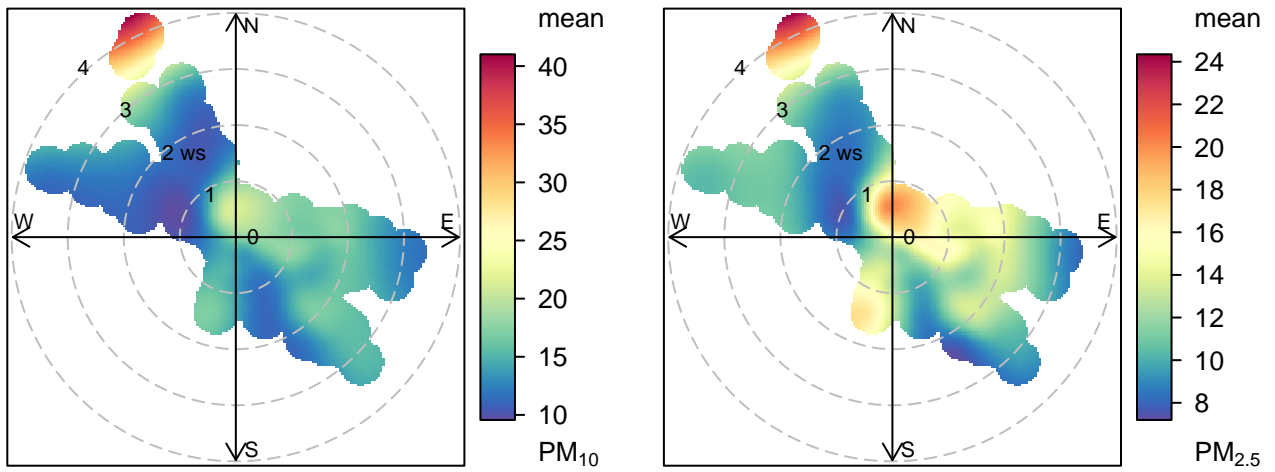


Eastern Grounds – 24-hour average PM_{2.5}



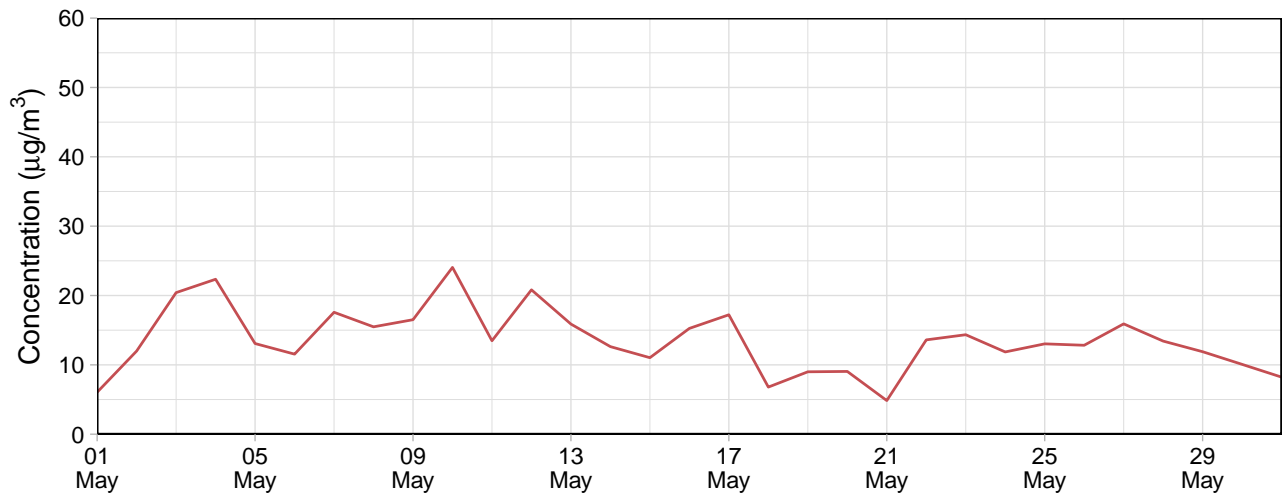

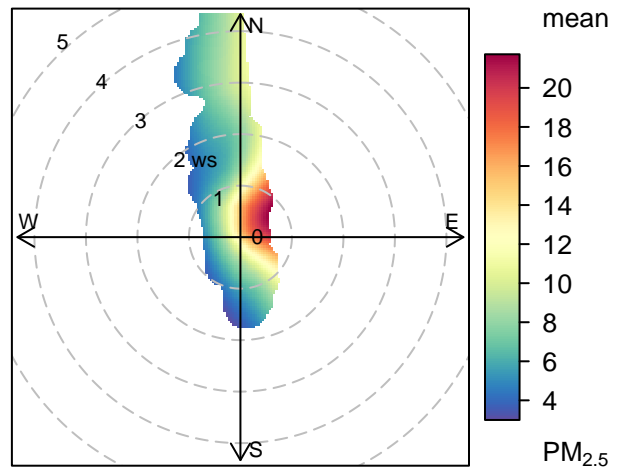
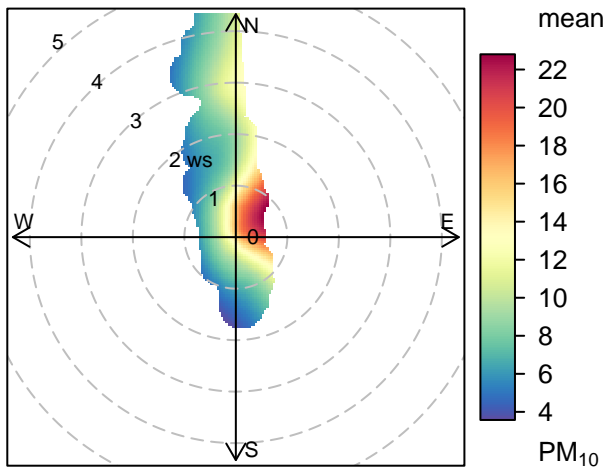


Southern Grounds – 24-hour average PM_{2.5}



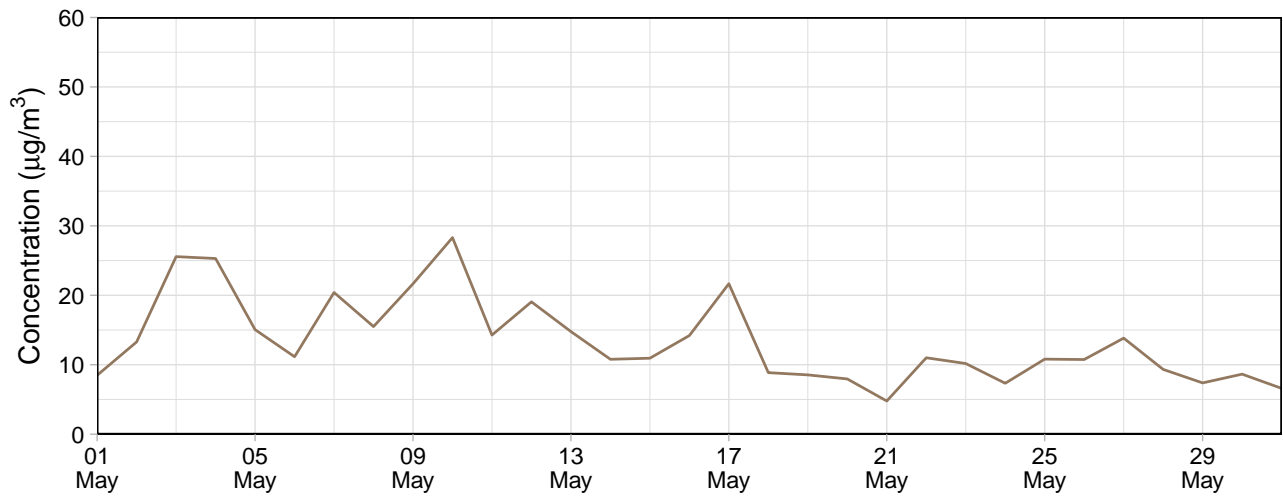

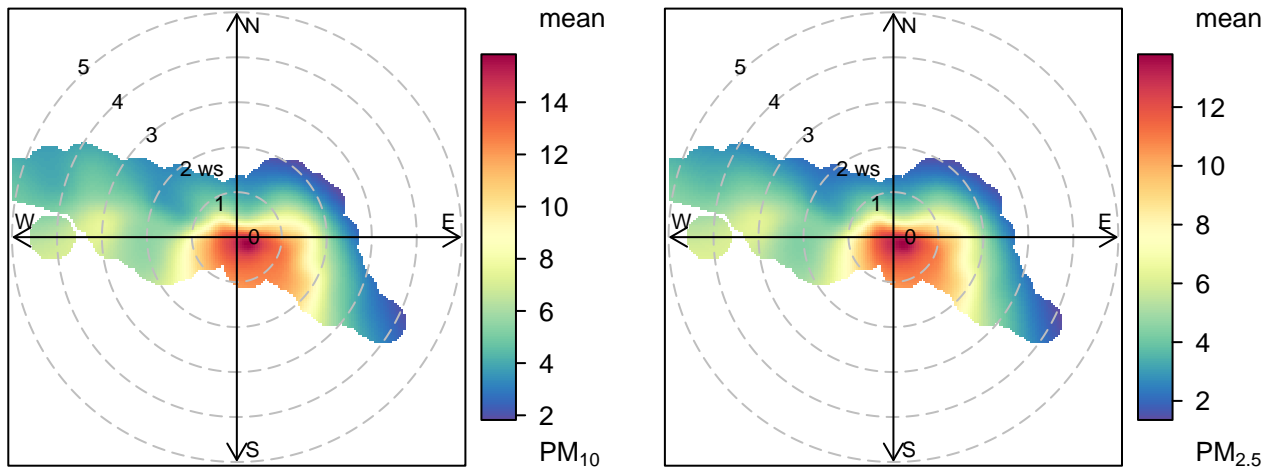


Northern Grounds – 24-hour average PM_{2.5}



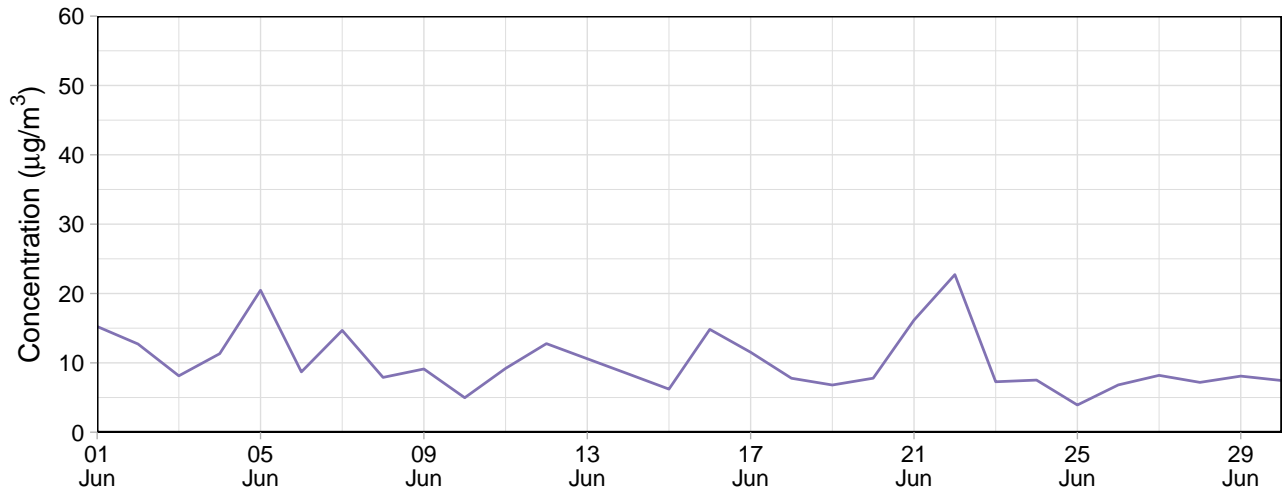

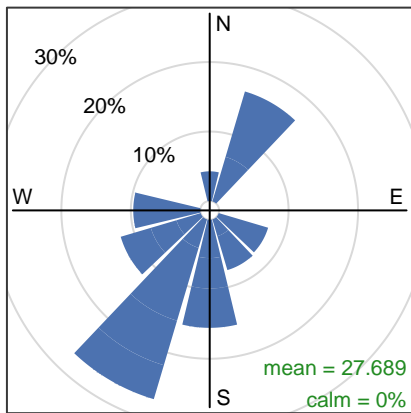

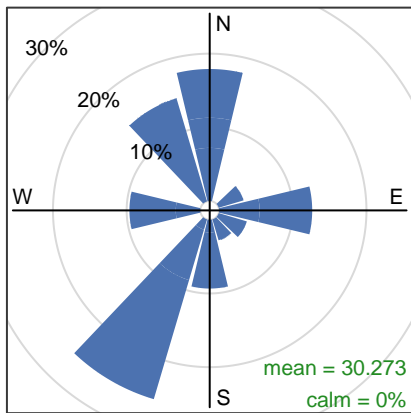
